A BILL

To amend the Wild and Scenic Rivers Act to designate certain river segments in Oregon as wild or scenic rivers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Lower Rogue Wild and
5 Scenic River Expansion Act”.

6 **SEC. 2. ROGUE RIVER ADDITIONS.**

7 (a) AMENDMENTS.—Section 3(a)(5) of the Wild and
8 Scenic Rivers Act (16 U.S.C. 1274(a)(5)) is amended—

1 (1) by striking “The segment” and inserting
2 “(A) The segment”; and

3 (2) by adding at the end the following:

4 “(B) ADDITIONAL AREAS.—In addition to
5 the segment described in subparagraph (A), the
6 following segments:

7 “(i) KELSEY CREEK.—

8 “(I) The approximately 2.2 miles
9 of Kelsey Creek from its headwaters
10 to the eastern section line of 32S 8W
11 sec. 30 as a recreational river.

12 “(II) The approximately 7.1
13 miles of Kelsey Creek from the east-
14 ern section line of 32S 8W sec. 30 to
15 the confluence with the Rogue River
16 as a wild river.

17 “(ii) EAST FORK KELSEY CREEK.—

18 “(I) The approximately 0.1 miles
19 of East Fork Kelsey Creek from its
20 headwaters to 0.1 miles downstream
21 of road 32-7-19.3 as a scenic river.

22 “(II) The approximately 4.7
23 miles of East Fork Kelsey Creek from
24 0.1 miles downstream of road 32-7-

1 19.3 to the confluence with Kelsey
2 Creek as a wild river.

3 “(iii) WHISKY CREEK.—

4 “(I) The approximately 0.6 miles
5 of Whisky Creek from the confluence
6 of the East Fork and West Fork to
7 0.1 miles downstream from road 33–
8 8–23 as a recreational river.

9 “(II) The approximately 1.9
10 miles of Whisky Creek from 0.1 miles
11 downstream from road 33–8–23 to
12 the confluence with the Rogue River
13 as a wild river.

14 “(iv) EAST FORK WHISKY CREEK.—

15 “(I) The approximately 0.1 miles
16 of East Fork Whisky Creek from its
17 headwaters to 0.1 miles downstream
18 of road 34–8–1 as a scenic river.

19 “(II) The approximately 3.7
20 miles of East Fork Whisky Creek
21 from 0.1 miles downstream of road
22 34–8–1 to the confluence with Whisky
23 Creek as a wild river.

24 “(v) WEST FORK WHISKY CREEK.—

25 The approximately 4.8 miles of West Fork

1 Whisky Creek from its headwaters to the
2 confluence of the Rogue River as a wild
3 river.

4 “(vi) BIG WINDY CREEK.—

5 “(I) The approximately 1.5 miles
6 of Big Windy Creek from its head-
7 waters to 0.1 miles downstream from
8 road 34–9–17.1 as a scenic river.

9 “(II) The approximately 5.8
10 miles of Big Windy Creek from 0.1
11 miles downstream from road 34–9–
12 17.1 to the confluence with the Rogue
13 River as a wild river.

14 “(vii) EAST FORK BIG WINDY
15 CREEK.—

16 “(I) The approximately 0.2 miles
17 of East Fork Big Windy Creek from
18 its headwaters to 0.1 miles down-
19 stream from road 34–8–36 as a scenic
20 river.

21 “(II) The approximately 3.7
22 miles of East Fork Big Windy Creek
23 from 0.1 miles downstream from road
24 34–8–36 to the confluence with Big
25 Windy Creek as a wild river.

1 “(viii) LITTLE WINDY CREEK.—

2 “(I) The approximately 1.1 miles
3 of Little Windy Creek from its head-
4 waters to 0.1 miles downstream of
5 road 34–8–36 as a scenic river.

6 “(II) The approximately 1.9
7 miles of Little Windy Creek from 0.1
8 miles downstream of road 34–8–36 to
9 the confluence with the Rogue River
10 as a wild river.

11 “(ix) HOWARD CREEK.—

12 “(I) The approximately 0.3 miles
13 of Howard Creek from its headwaters
14 to 0.1 miles downstream of road 34–
15 9–34 as a scenic river.

16 “(II) The approximately 6.9
17 miles of Howard Creek from 0.1 miles
18 downstream of road 34–9–34 to the
19 confluence with the Rogue River as a
20 wild river.

21 “(x) MULE CREEK.—

22 “(I) The approximately 0.2-mile
23 section of Mule Creek from the head-
24 waters to 0.1 miles downstream from
25 road 32–9–15.1 as a scenic river.

1 “(II) The approximately 11.2
2 miles of Mule Creek from 0.1 miles
3 downstream from road 32–9–15.1 to
4 the confluence with the Rogue River
5 as a wild river.

6 “(xi) GRAVE CREEK.—

7 “(I) The approximately 1.6-mile
8 section of Grave Creek from the con-
9 fluence of Wolf Creek downstream as
10 a scenic river.

11 “(II) The approximately 8.2-mile
12 section of Grave Creek from 1.6 miles
13 downstream of the confluence of Wolf
14 Creek to the confluence with the
15 Rogue River as a recreational river.

16 “(xii) ANNA CREEK.—The approxi-
17 mately 3.5-mile section of Anna Creek
18 from its headwaters to the confluence with
19 Howard Creek as a wild river.

20 “(xiii) MISSOURI CREEK.—

21 “(I) The approximately 2.6 miles
22 of Missouri Creek from its headwaters
23 to north section line of 33S 10W sec.
24 25 as a scenic river.

1 “(II) The approximately 2.2-mile
2 section of Missouri Creek from north
3 section line of 33S 10W sec. 25 to the
4 confluence with the Rogue River as a
5 wild river.

6 “(xiv) JENNY CREEK.—

7 “(I) The approximately 0.3-mile
8 section of Jenny Creek from its head-
9 waters to 0.1 miles downstream from
10 road 34–9–7 as a scenic river.

11 “(II) The approximately 4.6-mile
12 section of Jenny Creek from 0.1 miles
13 downstream from road 34–9–7 to the
14 confluence with the Rogue River as a
15 wild river.

16 “(xv) RUM CREEK.—

17 “(I) The approximately 2-mile
18 section of Rum Creek from its head-
19 waters to 0.1 miles downstream from
20 road 34–8–34 as a scenic river.

21 “(II) The approximately 2.4-mile
22 section of Rum Creek from 0.1 miles
23 downstream from road 34–8–34 to
24 the confluence with the Rogue River
25 as a wild river.

1 “(xvi) EAST FORK RUM CREEK.—

2 “(I) The approximately 0.5-mile
3 section of East Rum Creek from the
4 headwaters to 0.1 miles downstream
5 of road 34–8–10.1 as a scenic river.

6 “(II) The approximately 1.5-mile
7 section of East Rum Creek from 0.1
8 miles downstream of road 34–8–10.1
9 to the confluence with Rum Creek as
10 a wild river.

11 “(xvii) WILDCAT CREEK.—The ap-
12 proximately 1.7-mile section of Wildcat
13 Creek from its headwaters downstream to
14 the confluence with the Rogue River as a
15 wild river.

16 “(xviii) MONTGOMERY CREEK.—The
17 approximately 1.8-mile section of Mont-
18 gomery Creek from its headwaters down-
19 stream to the confluence with the Rogue
20 River as a wild river.

21 “(xix) QUARTZ CREEK.—

22 “(I) The approximately 0.5-mile
23 section of Quartz Creek from its head-
24 waters to 0.1 miles downstream from
25 road 35–9–1.2 as a recreational river.

1 “(II) The approximately 2.8-mile
2 section of Quartz Creek from 0.1
3 miles downstream from road 35–9–1.2
4 to the confluence of the North Fork
5 Galice Creek as a scenic river.

6 “(xx) HEWITT CREEK.—

7 “(I) The approximately 1.3-mile
8 section of Hewitt Creek from its head-
9 waters to 0.1 miles downstream of
10 road 33–9–21 as a scenic river.

11 “(II) The approximately 1.3-mile
12 section of Hewitt Creek from 0.1
13 miles downstream of road 33–9–21 to
14 the confluence with the Rogue River
15 as a wild river.

16 “(xxi) BUNKER CREEK.—The approxi-
17 mately 6.6 miles of Bunker Creek from its
18 headwaters to the confluence with the
19 Rogue River as a wild river.

20 “(xxii) DULOG CREEK.—

21 “(I) The approximately 0.8 miles
22 of Dulog Creek from its headwaters to
23 0.1 miles downstream of road 34–8–
24 36 as a scenic river.

1 “(II) The approximately 1.0
2 miles of Dulog Creek from 0.1 miles
3 downstream of road 34–8–36 to the
4 confluence with the Rogue River as a
5 wild river.

6 “(xxiii) GALICE CREEK.—The ap-
7 proximately 2.2 miles of Galice Creek from
8 the confluence with the North and South
9 Forks of Galice Creek to the confluence
10 with the Rogue River as a recreational
11 river.

12 “(xxiv) NORTH FORK GALICE
13 CREEK.—

14 “(I) The approximately 1.2-mile
15 section of North Fork Galice Creek
16 from its headwaters to 0.1 miles up-
17 stream of road 34–8–36 as a scenic
18 river.

19 “(II) The approximately 4.5-mile
20 section of North Fork Galice Creek
21 from 0.1 miles upstream of road 34–
22 8–36 to the confluence with Galice
23 Creek as a recreational river.

24 “(xxv) QUAIL CREEK.—

1 “(I) The approximately 0.7 miles
2 of Quail Creek from its headwaters to
3 0.1 miles downstream from road 32–
4 9–14.2 as a scenic river.

5 “(II) The 1.8-mile segment of
6 Quail Creek from 0.1 miles down-
7 stream from road 32–9–14.2 to the
8 confluence with the Rogue River as a
9 wild river.

10 “(xxvi) MEADOW CREEK.—The ap-
11 proximately 4.1 miles of Meadow Creek
12 from its headwaters to the confluence with
13 the Rogue River as a wild river.

14 “(xxvii) RUSSIAN CREEK.—

15 “(I) The approximately 0.4 miles
16 of Russian Creek from its headwaters
17 to 0.1 miles downstream from road
18 33–8–21 as a scenic river.

19 “(II) The approximately 2.2
20 miles of Russian Creek 0.1 miles
21 downstream from road 33–8–21 to
22 the confluence with the Rogue River
23 as a wild river.

24 “(xxviii) ALDER CREEK.—The ap-
25 proximately 1.2 miles of Alder Creek from

1 its headwaters to the confluence with the
2 Rogue River as a wild river.

3 “(xxix) BOOZE CREEK.—The approxi-
4 mately 1.5 miles of Booze Creek from its
5 headwaters to the confluence with the
6 Rogue River as a wild river.

7 “(xxx) BRONCO CREEK.—The ap-
8 proximately 1.8 miles of Bronco Creek
9 from its headwaters to the confluence with
10 the Rogue River as a wild river.

11 “(xxxii) CENTENNIAL GULCH
12 CREEK.—The approximately 1.9 miles of
13 Centennial Gulch Creek from its head-
14 waters to the confluence with the Rogue
15 River as a recreational river.

16 “(xxxiii) COPSEY CREEK.—The ap-
17 proximately 1.5 miles of Copsey Creek
18 from its headwaters to the confluence with
19 the Rogue River as a wild river.

20 “(xxxiiii) CORRAL CREEK.—The ap-
21 proximately 0.5 miles of Corral Creek from
22 its headwaters to the confluence with the
23 Rogue River as a wild river.

24 “(xxxv) COWLEY CREEK.—The ap-
25 proximately 0.9 miles of Cowley Creek

1 from its headwaters to the confluence with
2 the Rogue River as a wild river.

3 “(xxxv) DITCH CREEK.—

4 “(I) The approximately 0.5-mile
5 section of Ditch Creek from its head-
6 waters to 0.1 miles downstream from
7 road 33–5–9.2 as a scenic river.

8 “(II) The approximately 1.9-mile
9 section of Ditch Creek from 0.1 miles
10 downstream from road 33–5–9.2 to
11 its confluence with the Rogue River as
12 a wild river.

13 “(xxxvi) FRANCIS CREEK.—The ap-
14 proximately 0.9 miles of Francis Creek
15 from its headwaters to the confluence with
16 the Rogue River as a wild river.

17 “(xxxvii) LONG GULCH.—

18 “(I) The approximately 1.4-mile
19 section of Long Gulch from the head-
20 waters to 0.1 miles downstream from
21 road 34–9–21 as a scenic river.

22 “(II) The approximately 1.1-mile
23 section of Long Gulch from 0.1 miles
24 downstream of road 34–9–21 to the

1 confluence with the Rogue River as a
2 wild river.

3 “(xxxviii) BAILEY CREEK.—

4 “(I) The approximately 1.0-mile
5 section of Bailey Creek from its head-
6 waters to 0.1 miles downstream from
7 road 34–8–22.2 as a scenic river.

8 “(II) The approximately 2.1-mile
9 section of Bailey Creek from 0.1 miles
10 downstream from road 34–8–22.2 to
11 the confluence of the Rogue River as
12 a wild river.

13 “(xxxix) SHADY CREEK.—The ap-
14 proximately 0.7 miles of Shady Creek from
15 its headwaters to the confluence with the
16 Rogue River as a wild river.

17 “(xl) SLIDE CREEK.—

18 “(I) The approximately 0.5-mile
19 section of Slide Creek from its head-
20 waters to 0.1 miles downstream from
21 road 33–9–6 as a scenic river.

22 “(II) The approximately 0.7-mile
23 section of Slide Creek from 0.1 miles
24 downstream of road 33–9–6 to the

1 confluence with the Rogue River as a
2 wild river.

3 “(C) IN GENERAL.—River segments re-
4 ferred to in subparagraph (B) shall include an
5 average of 640 acres per mile measured from
6 the ordinary high water mark on both sides of
7 the river. All such wild, scenic, and recreation
8 areas shall be managed as part of the Rogue
9 Wild and Scenic River.”.

10 (b) WITHDRAWAL.—Subject to valid rights, the Fed-
11 eral land within the boundaries of the river segments des-
12 ignated by subparagraph (B) of section 3(a)(5) of the
13 Wild and Scenic Rivers Act (16 U.S.C. 1274(a)(5)), as
14 added by subsection (a) of this section, is withdrawn from
15 all forms of—

16 (1) entry, appropriation, or disposal under the
17 public land laws;

18 (2) location, entry, and patent under the mining
19 laws; and

20 (3) disposition under all laws pertaining to min-
21 eral and geothermal leasing or mineral materials.
